TRANSPORT

Transport to and from George Domestic Airport will be provided but all transport or flights to the airport is the responsibility of the participant.

Participants will be collected at 14:00 on Thursday 7th of May 2020. And returned to George Domestic by 11:00 on Sunday 7th of May.

Personal vehicles to and from the lodging as well to and from workshop locations are welcome.

LODGING

Lodging is provided however participants must be willing to share rooms with one other person. The lodging is a large property based in Brenton-on-Sea that can house all participants. Participants will be responsible for cleaning up any mess made by themselves.

MEALS

Light breakfasts and a substantial dinners are provided. Any meals in-between are the responsibility of the participant however bread and spreads will be provided. A communal fridge is available for use. Beverages are the responsibility of the participants however some basic refreshments will be available. **NB: Please provide insight to any food allergies.** We do our best to cater for abnormal dietary restriction but it is best advised that we are informed ahead of time. Certain meals on the menu consist of red meat.

Socialising between lessons and shoots with other participants is encouraged. Meal times, especially dinner are considered social events and a good times to enjoy oneself and interact.

WORKSHOP DETAILS

6 visits to locations. This is subject to change but include choices from Coney Glen (Knysna Heads), Brenton-on-Sea, Knysna forests, Gerikes Point and Sparrebocshe beach depending on how adventurous the group is. The order of these locations will be assessed closer to the time to take advantage of the best conditions

In-camera on location

- Reading conditions
- Finding and locating compositions,
- Long exposures using ND filters
- Taking multiple exposures for blending dynamic range
- · Coverage on additional image quality techniques like reducing flare and focus stacking.

Post-processing (between morning and evening shoots)

- Basic edits (Lightroom, Photoshop)
- Blending multiple exposures (Photoshop only)
- Creative edits using luminosity masking. (Photoshop only).

FORCE MAJEURE

For purposes of the terms & conditions described in this document, Force Majeure shall mean a cause or event such as; war or the threat of war, riots, terrorist activity, civil strife, governmental acts, industrial disputes, labor strikes, injunctions, natural disasters, nuclear disaster, fire, or unfavorable or adverse weather conditions that is not reasonably foreseeable or otherwise caused by or under the control of Stuart Apsey Photography. Any delay or failure in the performance by Stuart Apsey Photography shall be excused if and to the extent caused by the occurrence of a Force Majeure.

CANCELLATION POLICY

Stuart Apsey Photography reserves the right to alter or cancel any workshop, for any reason. In the unlikely event that we need to cancel a workshop we will refund all monies paid, in full with prime rate interest, or you have the option of receiving a credit in the amount of the workshop fee that may be applied in full to pay for a future workshop to be used within 24 months of the original workshop you are registered to participate in. Stuart Apsey Photography cannot be responsible for any travel expenses or non-refundable purchases, deposits, or reservations. It is recommended that you purchase trip insurance.

Notification of cancellation will be made via either a telephone call or an e-mail to you. We cannot be responsible for voicemail messages and e-mails not being received in a timely matter due to your service provider(s).

WITHDRAWAL & REFUND POLICY

All workshop withdrawal requests by the workshop participant must be in writing and received either by e-mail, and acknowledged by Stuart Apsey Photography. There are NO EXCEPTIONS TO THIS POLICY, even for medical emergencies. Based on cancellation date, the following apply:

• Greater than 46 days before the workshop start date: refund of workshop fee, less the workshop deposit.

• Within 45 days of the start of the workshop: no refund.

No matter when you cancel, if we are able to fill your space, we will provide a 100% refund of any payments made. Refunds will be paid by the same method that the original payment was made.

TRAVEL INSURANCE

We highly recommend you purchase travel insurance for your workshop and travel expenses. Many travel insurance providers offer products that do more than protect the money you invest in your trip — they protect you in unforeseen circumstances. We suggest a plan which offers coverage for lost baggage, missed connections, and trip cancellation should you have a medical problem that prevents you from attending. Workshop registrations are accepted on a first come, first served basis. All workshop pricing is in South African Rands. All fees may via EFT. Alternative arrangements can be made by PayPal deposit though this is not the prefered method and must be arranged before hand. All fees stated are only for workshop tuition and expenditures listed in the workshop details. A non-refundable deposit, the amount will be specified in the workshop information, is required at the time of your registration. Reservations for workshops cannot be held without a deposit. The balance of the workshop fee is due no later than 30 days prior to the workshop start date. Should this final payment fail to process or be received by the date specified, we reserve the right to treat the reservation as cancelled and retain the deposit. If a reservation is made 45 days or less prior to the workshop start date, then the full amount is payable at the time of reservation.

NOW THEREFORE, in consideration of the execution and delivery of this Agreement, the other mutual premises and covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Participant and Provider, acting for themselves and their respective heirs, representatives, successors and assigns, hereby agree as follows:

1. Participant has been made fully aware that their presence and attendance at the Workshop entails a degree of risk, danger and physical exertion, including, without limitation, situations in which the Participant will may be in close proximity to wild coastal sea waters. Participant knowingly and voluntarily accepts such risks and dangers as a condition precedent to its attendance at the Workshop.
